What is a Complete Street?


- Complete streets policies influence both decision making and actual structures in the community to create a safe and accessible transportation network for all
 - Policy and streets change with each situation and community
 - Safe, comfortable, and convenient for all
 - Happens as municipality/state updates streets within the budget

• Features can include:

- proper crossing walks
- wider sidewalks
- cycling lanes
- Medians
- Curb cuts (ADA compliant)
- Storm water management and greenery
- are ideally connected into public transit.
