Legislative Background

The Louisiana Health Care Commission was created by law in 1992 (R.S. 22:2161). It is a 47-member multi-disciplined advisory board which undertakes comprehensive review of complex health care issues facing Louisianians.

In 1999, the commission was transferred to the Department of Insurance Statutory authority and membership of the commission are contained in LA R.S. 22:2161.

Since its inception, the commission's membership has changed from its original makeup through Acts of the Legislature in 1995, 1997, 1999, 2004, 2012, and 2014.

Mission

There is hereby created the Louisiana Health Care Commission to review and study the availability and affordability of health care in the state.

The commission shall specifically examine the rising costs of health care in the state, including, but not limited to, the cost of administrative duplication; the costs associated with excess capacity and duplication of medical services; the costs of medical malpractice and liability; the formation and implementation of insurance pools that better assure citizens the ability to obtain health insurance at affordable costs and encourage employers to obtain health care benefits for their employees by increased bargaining power and economies of scale for better coverage and benefit options at reduced costs.

Further, the commission shall examine the implementation issues related to national health care reform initiatives.

Purpose

Through a broad perspective, the commission studies the issues affecting the availability, affordability and delivery of quality health care in Louisiana. The commission is also tasked with examining national health care reform initiatives.

The commission conducted public meetings to receive information and testimony from regional and national experts on health care issues. The commissioner of insurance submitted an annual report to the Legislature on the studies, actions and recommendations of the commission.

Executive Committee

The executive committee for the Louisiana Health Care Commission consists of the chair, vice chair and three LHCC's commission members representing health care providers, insurers and consumers. The mission of the Louisiana Health Care Commission Executive Committee is to plan the agenda for Louisiana Health Care Commission meetings, schedule any emergency meetings necessary between regular meetings and to propose subcommittee assignments. The Louisiana Health Care Commission Executive Committee held four meetings via conference call during this reporting period.

Membership

The Louisiana Health Care Commission is composed of health care experts and other interested parties, including health care insurers and providers, community leaders and representatives of various consumer interests. Membership also includes representatives from the governing boards of Louisiana's colleges and universities, the House and Senate Committees on Insurance and at-large appointments designated by the commissioner of insurance.

BYLAWS OF THE LOUISIANA HEALTH CARE COMMISSION

ARTICLE ONE

NAME

The name of this commission shall be the Louisiana Health Care Commission, created under the provisions of <u>R.S. 22:2161</u>, as created by Act 1068, Section 1 of the 1992 Legislative Session, and as subsequently amended from time to time. The commission shall be domiciled in Baton Rouge.

ARTICLE TWO

PURPOSE

- A. The purpose of this commission is to:
 - 1) Study the availability and affordability of health care in the state.
 - 2) Examine the rising costs of health care in the state, including but not limited to the cost of administrative duplication, the costs associated with excess capacity and duplication of medical services, the cost of medical malpractice and liability.
 - 3) Examine the adequacy of consumer protections, as well as the formation and implementation of insurance pools that better assure citizens the ability to obtain health insurance at affordable costs and encourage employers to obtain health care benefits for their employees by increased bargaining power and economies of scale for better coverage and benefit options at reduced costs.
 - 4) Examine the implementation issues related to national health care reform initiatives.
 - 5) Conduct public hearings to receive testimony about the availability and affordability of health care in the state.
 - 6) Receive further information and testimony from regional and national experts, when necessary, on health care access issues.
 - 7) Serve as an advisory body to the commissioner and shall submit to the commissioner its recommendations on all matters which it is charged to examine.
 - 8) Submit a yearly report on health care and health insurance. Which takes into consideration the recommendations, actions and studies of the commission, to the legislature prior to each annual regular session.

ARTICLE THREE

MEMBERS

- A. Membership of the commission shall be comprised as follows:
 - Three members appointed from a list of nominees submitted by the governing boards of state colleges and universities and by a dean from the business schools represented by the Louisiana Association of Independent Colleges and Universities;
 - 2) One member of the Senate Committee on Insurance appointed by the President of the Senate as an ex officio, nonvoting member;
 - 3) One member of the House Committee on Insurance appointed by the Speaker of the House of Representatives as an ex officio, nonvoting member;
 - 4) One member appointed by the secretary of the Department of Health and Hospitals;
 - 5) Five at-large members appointed by the Commissioner of Insurance;
 - 6) The Commissioner of Insurance or his designee, shall serve as ex officio;
 - 7) The remaining members shall be appointed by the Commissioner of Insurance from a list of nominees, one nominee to be submitted by each of the following:
 - (1) The Louisiana Insurers' Conference
 - (2) Louisiana Association of Health Plans
 - (3) America's Health Insurance Plans
 - (4) A domestic mutual, nonprofit health service and indemnity company
 - (5) Louisiana State Medical Society
 - (6) Louisiana Association for Justice
 - (7) Health Agents for America
 - (8) Agenda for Children
 - (9) Independent Insurance Agents & Brokers of Louisiana
 - (10) AARP Louisiana
 - (11) The National Federation of Independent Businesses

- B. All members shall be confirmed by the Senate.
- C. The members of the commission shall serve without compensation.
- D. The members shall serve for a term of two years.
- E. Vacancies
 - 1) Vacancies in the offices of the members shall be filled in the same manner as the original appointments for the unexpired portion of the term of the office vacated.
 - 2) Any member who misses four (4) meetings in any given year or three (3) consecutive meetings shall be considered vacating that seat.
 - 3) Vacancy may be declared upon the resignation, death, incapacity, or nonqualification of a member.

ARTICLE FOUR

OFFICERS

- A. The commissioner of insurance shall appoint a chairman and vice-chairman.
- B. Term of office for chairman and vice-chairman is two years.

ARTICLE FIVE

EXECUTIVE COMMITTEE

- A. The function of the executive committee is to exercise the powers of the commission which arise between regularly scheduled commission meetings or when it is not practical or feasible for the commission to meet.
- B. The committee will consist of the commission chair, the vice-chair and three commissioners representing the following groups: provider, insurer and consumer. Except for the chair and vice-chair, members will serve **two-year staggered terms**. Members will be selected by the chair.
- C. The committee shall meet as necessary. A majority of the members shall constitute a quorum.
- D. Key Responsibilities
 - 1) Setting the agenda for commission meetings.
 - 2) Strategic Planning
 - 3) Performance Measures
 - 4) Proposing subcommittee assignments (including proposed Chairs) to the commission and coordination of the work of the subcommittees.
 - 5) Any emergency planning or implementation between regularly scheduled meetings.

ARTICLE SIX

MEETINGS

- A. A quorum for the transaction of business by the commission shall be 40 percent of the filled seats, excluding the ex-officio members.
- B. All official actions of the commission shall require the affirmative vote of a majority of the quorum.

C. The commission shall meet twice in any one calendar year and may meet on the call of the chairman or upon the request of any three members.

ARTICLE SEVEN

COMMITTEES

The commission may establish committees, in such areas as may be directed by its membership. The chairman shall appoint the members of such committees and shall designate the chairman of each such committee. The duties and responsibilities of the committee will be determined by the commission membership. Each appointed committee shall make reports as the committee may deem appropriate.

ARTICLE EIGHT

PARLIAMENTARY AUTHORITY

A reasonably current version of <u>Robert's Rules of Order</u>, <u>Newly Revised</u> shall be the parliamentary authority for this commission.

ARTICLE NINE

AMENDMENT

These bylaws may be amended at any meeting of the membership. Amendments shall be made by a quorum of the membership at such meeting, PROVIDED proper notice is given to the members, together with a copy of the proposed changes, prior to the meeting. These bylaws may be further amended at any time in which the provisions of <u>R.S. 22:2161</u> are amended.

ARTICLE TEN

NOTICE

All notices relative to this commission are posted pursuant to the Open Meetings Law.

Chairperson Jeff Drozda called the meeting to order at 9:46 a.m.

Jeff Drozda included an overview of the subcommittee's work and suggested that the committee create studies on the high costs of pharmaceutical drugs, promoting home-based care and on promoting the use of specialty pharmacies.

John Overton spoke about the small business insurance options and providing consumers information on their options.

Derrell Cohoon, agreed with Jeff Drozda on high pharmaceutical costs and made reference to the high cost of in-patient care costs.

Katie Brittain noted that we are not ready for a solution and suggested beginning with an educational component or a study.

Jeff Drozda that the committee look at educating doctors on the cost of drugs that are prescribed to patients. Mr. Drozda also emphasized the issues surrounding brand and generic drug availability and their efficacies. Additionally, he noted the options for patients in both traditional and home-based care settings; noting that home-based care options are often less expensive than the care performed in many facilities.

Derrell Cohoon spoke about the high cost of care being broader than the cost of prescription drugs. Mr. Cohoon referenced the impacts of mandated benefits and how they influence the rise of health care.

Mike Bertaut emphasized a need transparency in how health care is financed. Mr. Bertaut noted a common misconception on where the health care dollar is spent. He also expressed interest in educating legislators on the biggest part of the state's budget by leading the charge for an educational forum for legislative leaders.

Katie Brittain referenced Mr. Bertaut's statement on where the average health care dollar is spent. Ms. Brittain noted that through legislation someone will be helped but someone will also be hurt. Ms. Brittain also emphasized a need to conduct more hearings to receive more data on the flow of the health care dollar and a expressed a desire to create an information packet.

Frank Opelka provided an update on the Mandated Health Benefits Commission. Deputy Commissioner Opelka noted that the goal is to get the commission restarted before the start of the legislative session. He also provided information that references how health insurance bills could potentially be scored differently based on statute and joint rule.

Jeff Drozda spoke about a recommendation to limit the previous studies that he mentioned to one or two high-cost areas. Mr. Drozda also noted the price-setting capabilities of drug manufacturers; mentioning that those companies are allowed to increase the price of drugs up to four times per year.

Derrell Cohoon emphasized the idea of a strong recommendation to the legislature.

Jeff Drozda noted that mandated benefits are causing the cost of health insurance to continue to go up because they are very expensive, and many times cater to a very specific group.

Crystal Lewis provided a summary of the recommendations mentioned throughout the meeting and asked members to provide comments to commission staff.

2023 Recommendations Subcommittee on Affordability and the Rising Cost of Health Care

- 1) Engage and Strengthen Louisiana Mandated Health Benefits Commission
- 2) Pharmacy Drug Cost Transparency
- 3) Mandated Long Term Services and Support Study Committee

Engage and Strengthen Louisiana Mandated Health Benefits Commission (R.S. 22:2187)

With the legislature increasing passage of mandates each year, it is important to understand the relation these mandates have to increases in health insurance premiums and costs to the state, to properly follow existing state law and to revise such law as needed.

Recommendation: As required by law, the commission appointees should be named as soon as possible in preparation for the upcoming legislative session. The commission should meet at least monthly; one month prior to and every month during a legislative session to accurately analyze the true costs of each mandate being considered and report that information to the appropriate legislative committees. The commission shall consider and report on all new and expanded mandates, and legislation may be needed to assist with proper implementation.

Pharmacy Drug Cost Transparency

With pharmacy drugs accounting for 26 cents on every health care dollar, there is a need for more education for both provider and patient when a drug is being prescribed. There are organizations such as Arrive Health, that uses real-time cost comparisons on generic and brand drugs. This information, which benefits the provider and patient, can be shared with the patient before leaving the doctor's office.

Recommendation: All medical providers and health systems should implement drug cost transparency technology within the next two to three years.

No legislation required.

MLTSS Study Committee

Many states continue to move toward offering more at-home health care options for those who do not need to be placed in an institutional setting. Managed Long Term Services and Support (MLTSS) can offer these options at a cost which may be significantly lower than other alternatives so that loved ones can continue to live independently.

Recommendation: The legislature should enact a study committee to direct the Louisiana Department of Health to review what other states have done in implementing MLTSS and report the findings back to the legislature and the Louisiana Health Care Commission. The study committee should contact the National MLTSS Health Plan Association to gather information on best practices.
